Scientific Data Acquired: Prepare an abstract outlining your objectives, techniques, findings, etc.

Samples of hydrothermal vent and plume waters were taken for chemical and microbiological analysis. Observations of bottom geology were made, with particular emphasis on hydrothermal system occurences, including mineral precipitates and bacterial colonies. Two samples of ambient plume waters were taken on this dive, one at 1080 m. and one at 960 m.

#### MISSION EVALUATION:

Limitations, failures, or operational problems noted:

The major objective of this dive, to locate and sample "Pele's vents" hydrothermal field, was not achieved, primarily because of problems with the sub tracking system. There were also problems with the sub video and still camera system and temp. probes.

Recommendations for corrective action or improvement:

Fix tracking system asap.

Fix video and still camera system.

Fix and calibrate temp. probes.

In your opinion, did the mission essentially achieve its purpose? Compare actual work accomplished with the work that was expected to be accomplished.

No, because of limitations noted above. Two ambient samples were taken in place of the vent samples desired. Samples of bacterial colonies were observed, but were not sampled because Titanium water sampler was in manipulator arm.

Two ambient water samples.

- 1. Titanium water sampler at 1080 m.
- Niskin water sampler at 960 m; sample lost on recovery.
