The dive was intended to sample lava from the Penguin Bank volcano and to sample overlying coral reefs for dating. No lava was encountered or sampled. However, a whole series of drowned coral reefs were found and 10 samples of coral collected. The "Fingers" of Penguin Bank, well known to local fishermen, prove to be drowned patch reefs and not volcanic constructs.
