Collected microbial mat samples from boulder field at Pele's Vents and from rim of North East Pit Crater near 1000 Fingers Vent field. Also collected water samples from boulder field at Pele's Vents using 3 major samplers, 1 La Bomba sampler and 3 Niskin bottles. Recovered 1 shrimp trap and 4 glass wool microbial enrichment chambers from Pele's Vents.
